Award Program Critique

The first fourteen years of our Chapter Awards Program utilized a banquet format for the formal award presentations with each attendee assigned a place setting at a sit-down dinner. The Awards Committee for the 2003 Program elected to modify the format to allow more freedom of movement during the event. Those who are familiar with ACI International Convention "Mixers" acknowledge that a ballroom with strategically placed tables of hot hors d'oeuvres with accompanying cocktail tables and cash bars provide the freedom of movement of attendees and satisfy the minimum needs for food and drink. This is the format that was selected by the Committee due to its simplicity of attendee logistics.

The anticipated advantages of the modified format were to be primarily realized in the event registration process. Historically, the registration has been a huge bottleneck as attendees must be recorded and assigned specific table seating. The significant numbers that fail to register and substitute others at the final moments aggravates the process. With the "free-style" format, attendees are checked off and admitted to the ballroom expeditiously.

The summary of complaints reflects a condition of too much freedom in the "free-style" format. Those that were pleased ate the hors d'oeuvres to their fill and fellowshipped to the detriment of the formal program; while those that complained did not get anything to eat and could not follow the formal program. The Committee produced two full pages of specific complaints and recommendations that will not be introduced here, but it appears the "free-style" format must be modified if it is to be utilized in the future.

The ballroom was arranged with a podium and theater seating in the center isolated by full wall partitions. The wings on either side of the theater seating contained the food and cocktail tables and beverage bars. Notwithstanding that the audio system was operable throughout the ballroom, it was difficult to commence the formal

presentations at the appointed time. It was noted however that the formal presentations were concluded in less than one hour! This demonstrates the potential of this format and many stayed well beyond the formal program to socialize.

The Committee consensus is to suspend the food and drink dispensing during the formal presentations; limiting it to pre- and post-formalities. Since the attendees were not prepared for this format change, the menu and format will be advertised in the registration documents. It is expected that refinements made for the next program will reduce the number of complaints and insure the maximum benefits for all.
