



Our speaker was Chapter member Harry Moats, President of Precision Concrete Construction of Alpharetta, GA. His topic was, "A Concrete Contractor's Experience with Self-Consolidating Concrete". Harry related his first experience with SCC on the High Museum of Art at Woodruff College project in Atlanta. In this project all the walls and columns were exposed architectural as well as structural concrete and the client wanted "white" concrete at the cost of plain pcc. Numerous full-size wall mock-ups were constructed to determine the mix design variables influence on architectural finish. They had to omit any pozzolans from the mix to get the 'whitest' color, which produced a higher heat of hydration that reacted with the form release oil. The form material was also a variable on this job. They finally selected MDO plywood to balance between "air absorption" and surface texture.

Harry remarked that SCC replicates detail better than conventional concrete and is so fluid it will find any cracks or holes in the formwork. He said the formwork had to be of the highest capacity because the pours were the full height and bracing had to be stronger than usual. Pour times and rates were held to a tight schedule to minimize variables that could influence the surface texture. He said that SCC permitted the achievement of "precast quality" in a cast-in-place field condition. Harry had an article on this project published in the *Concrete Industry Board Bulletin* Spring 2006 issue.
